

OHLS extension and Countryside Stewardship Higher Tier -

We have some good news to share, though it comes with a caveat. OF&G producer licensees in England will have received an email from OF&G with some details relating to this already.

The English Organic Forum (EOF) more recently picked up a problem that OF&G and others had been highlighting regarding issues many organic farmers in England with Organic Higher Level Stewardship agreements were facing — in that their agreements were not being extended whereas their non-organic counterparts could be offered this HLS extension.

This decision came from the Rural Payments Agency and Defra who, when challenged, suggested issues were insurmountable and referred to European Commission policy restrictions on funding and 'administrative burden'.

Following a great many meetings and with the key support of OF&G and the Soil Association, along with the testimony of farmers affected, the wrong has been addressed to some degree.

Natural England and the RPA are assessing each agreement expiring in 2021 to advise whether they are eligible for an extension. They will contact all affected organic farmers. This will help OHLS agreement holders with agreements expiring this year.

However, it still leaves a problem for those farmers with agreements that expired in 2019 and 2020, since Defra has advised that the change in policy can't be applied retrospectively.

The EOF is keen to see this iniquity resolved and are looking at the options available.

Sustainable Farming Incentive Apply by 11 April 2021

Phase 1 Pilot – Open for Expression of Interest by organic farmers

Recently Defra announced the launch of the Sustainable Farming Incentive and opened an Expressions of Interest for Phase 1 of the Pilot.

This will allow Defra to explore how well the system and the standards work in practice. The English Organic Forum has been working with Defra to look in detail at the proposed eight SFI standards, to see how they fit (or conflict) with organic production standards. The SFI is aimed at all farmers, including organic farmers.

We are keen that organic farmers in different regions and operating different systems are included in the Pilot – so please put in an Expression of Interest by 11th April.

It is important to note that if you are already a stewardship scheme holder you may not be eligible for this first phase of the SFI Pilot.

From the SFI blog at GOV.UK:

For the first phase of piloting, a farmer is only eligible if they:

- are a recipient of the Basic Payments Scheme, registered on the Rural Payments Agency system
- enter land parcels (fields) into the pilot that do not have an existing

- agri-environment agreement on them
- have management control of the land for the duration of the pilot. They must either own the land with management control or have a tenancy of enough length to implement their pilot agreement (including landlord's permission if required)
- enter land parcels that are in England
- enter land parcels that are not common land

If you think you might be able to take part we would encourage you to apply. This is very quick and easy and does not commit you.

If we don't have organic farmers included in this first phase of the SFI Pilot then we won't be able to demonstrate how organic farmers meet (and exceed in most cases) the SFI standards. Defra is also keen to see what the barriers to participation are for organic farmers, so that changes can be made in the standards' content and/or coverage.

We are convinced that an organic system approach is a very good way to meet the objectives of ELM, deliver public goods, provide good value for money and has compliance built in through the annual inspection, verification and certification process.

It is important therefore that we are in a position to prove it so please express your interest by 11th April.

Defra state that their ambition is 'to extend eligibility to include farmers who aren't eligible for, or don't claim, BPS. We also might add specific farm types not eligible for the first phase, like farms on common land.'

Information on what the next phase will look like or what the eligibility criteria is has yet to be decided.

We will continue to ask for clarification on eligibility and with colleagues across the farming industry will look at ways to help Defra find a way to widen inclusion.

Victoria Prentis MP says positive words in support of the organic sector

Victoria Prentis MP, the Parliamentary Under Secretary of State, Minister for Farming Fisheries and Food, gave the thumbs up to the organic sector.

She said in a recent letter to the English Organic Forum[1] that "This is the beginning of a new chapter for the UK to set an ambitious course for the UK's organic sector." Great news indeed.

With the Minister's answers to Parliamentary Questions on 18th March she helpfully reinforced this message when she referred to organic export and domestic market opportunities. Minister Prentis said that Defra is working alongside the Department of International Trade through their Open Doors programme, as part of the Government's multi-pronged approach to support of the organic sector.

She explained that the Government is also working with organic businesses to reduce administrative burden and is considering how the new Environmental Land Management scheme can best meet the needs of organic producers.

The English Organic Forum recently produced a policy paper: Why Organic – contributing productively to future farming and food policy[2].

This outlines all the reasons why organic is good, so we are pleased to see that Victoria Prentis MP, and her team at Defra are taking note of the organic opportunity.

Government consultation on the regulation of genetic technologies

OF&G response to the government's consultation on the regulation of genetic technologies

Traditional breeding is a concept that has brought about a range of definitions. Traditional would be seen by many as either in-field or in greenhouse cross-fertilisation. Some breeding techniques, however, are highly invasive and are not traditional.

We believe that genome editing is both invasive and disruptive and therefore cannot be equated to a traditional method of seed breeding.

OF&G is an active member of the English Organic Forum and IFOAM International and IFOAM Europe and we support full alignment with the international organic movement's position that genome editing is a genetic engineering technology and its process and products are Genetically Modified Organisms as defined by the EU Directive on GMOs (Directive 2001/18).

Consequently, we believe that all gene editing should be regulated as GMOs, in accord with the European Court of Justice Ruling of July 2018. This is consistent with scientific concepts and terminology and international treaties including the Cartagena Protocol.

We recognise gene editing is a developing technology which is now more available since recent advances in



GMOs and gene editing and the regulation of genetic technologies in agriculture

genome sequencing and may have a role to play in future farming and food systems. We also recognise that some farmers may wish to use the products of gene editing and some consumers may be willing to purchase gene edited products.

We therefore agree with the long-established UK and EU policy that different approaches to agriculture (in particular organic, non-GM conventional and GM conventional) should coexist and thereby enable farmers to choose which approach they wish to follow and give consumers the choice of buying products from the farming system they wish to support.

Market Information

Conventional wheat futures have weakened to £198 (at time of writing) having been trading at £200 or above throughout the start of 2021 and so perhaps we will start to see the conventional market falling back to more usual levels. This is important as the organic price is holding up which helps widen the organic premium and keeps organic cereal producers from decertifying. We have heard of a couple of farmers taking the decision to guit organic cereal production when the premium then could achieve was just £50 per tonne. Their view being their only profitable organic crop they grew was organic milling oats.

With little domestic wheat to trade values remain reasonable at £265 - £270 ex farm. The discount for feed barley is larger than has historically been the case at about £30 + and it is strange that organic feed companies have not followed the lead of the conventional market and started to utilise more organic barley in their rations especially as protein prices are so high. Using more barley would keep feed costs lower.

Crop reports are good with winter crops coming out of the winter looking well and recent drier weathers allowing spring drilling to progress well.

Reports of new crop organic feed wheat values equating to £240 ex farm mean we might start the 2021 harvest at a higher level than we did this season and perhaps at a premium of £70 over conventional values. With reports of the organic market growing at 12% year on year it seems organic grain producers are sharing in the benefits of a growing organic market.

Organic Livestock Trends: OLMC

ORGANIC PRIME BEEF CATTLE

Trade for all cattle continues to remain robust with good returns for producers. The Organic Prime market has been stable for the last six weeks with little issue in placing stock offered. Many producers will be grateful that turn-out is just around the corner as many are experiencing shortages of both straw and forage.

ORGANIC CULL COWS

A good demand for manufacturing meat has kept the cow trade strong; with numbers coming through typically being lower at this time of year the lower number of stock available has kept prices high.

FINISHED LAMBS

The Lamb trade is still surprisingly buoyant with most abattoirs on the look out for stock. The returns for quality, in specification, carcases remains extremely high. The outlook is fair leading up to Easter but will the trade be able to hold at these levels or will consumers start to shy away at the inevitable price increase in the shop?

ORGANIC STORE STOCK

With the country still in lockdown the strong demand for beef and lamb to eat at home continues and demand for Organic beef and lamb has risen as consumers increasingly look towards the Organic quality end of the market.

Lamb and beef prices have exceeded producers' expectations and this trend looks likely to continue, at least until we see a flush of cattle in the Autumn.

Store cattle prices are very buoyant

with finishers and graziers hungry for cattle as the number of cattle available is below what we would normally expect to see at this time of year.

Demand for organic dairy cattle also remains strong with demand currently far exceeding supply.

Cattle are now being turned out in a number of areas and let's hope that the Spring rainfall is better than last year.

The future of lockdown and overseas holidays is unpredictable but it is likely that far fewer of us will be holidaying abroad which may have a positive effect on demand in the red meat sector. Although feed prices look to remain high, the future for producers is looking good, at least in the medium term.

Arla's price increases reflect positive organic sentiment after difficult 2020

Last year was a mixed year for organic farmgate milk prices in Europe, and certainly for the UK, with France having its best year since 2015, Germany its secondbest year, but The Netherlands, the UK and Denmark having their worst year since 2017, according to a price analysis by organic specialist Daykin Partnerships.

UK organic milk prices for 2020 averaged 38ppl, which is 1.6p down on the four-year average of 39.6p and also 2ppl down on the 40p+ average



that the sector has enjoyed since 2017. Prices first climbed above 40p in July 2017 and stayed above the threshold until September 2019 after which prices steadily declined through much of 2020, to a low of 37.3p. They then before picking up slightly in October. Now, though, Arla's latest price move of 1.3p for April for a standard litre propels its price above 38p for the first time since April last year.

In the EU Germany had the highest organic milk price in 2020 of 43.7p, which was up over 1p on the year before, followed by France with 41p, The Netherlands at 39.8p, and Denmark at 37.6p. October saw the German price come within 0.3p of its record price and 1ppl off the highest price recorded in Europe.

The question now is whether the

rampant conventional dairy markets, which are at near record highs for some commodities, will also have a knock-on beneficial effect on the organic sector.

The answer is that they should! The tariff-free Brexit deal and the easing of the US tariffs (admittedly for four months) will both undoubtedly help the free-flow of exported products, and the vaccine rollout should free-up food service shortly. Covid has been good for organic sales, and for the organic ethos, so there should be another positive driver here.

However, milk volumes are growing in Europe, and this could unsettle the market again if there is not a corresponding increase in organic milk demand. French organic milk volumes are up 6.5% for January

compared to last year, and German organic volumes are also up 3.6% on last year. These two countries account for just under 40% of all EU organic milk volumes. Denmark and the UK are two other big suppliers, with 14% and 13% of EU volumes respectively, but their volumes should be static if organic volumes are in line with conventional ones.

It is early days still on how the organic milk market will react to the soaring conventional market, but the sign from Arla with its two consecutive price rises is encouraging after a challenging 2020.

The Commission recently published its final report in which it sets out its vision. The report fails to address many of the fundamental challenges we face.

OF&G Chief Executive Roger Kerr, wrote a letter highlighting some of the significant implications for UK agriculture if the recommendations of the report were to be adopted.

Pandemic consumer trends boost organic



Organic market year-on-year sales growth reached 12.6 per cent in 2020, outperforming growth in the non-organic sector with a tenth consecutive year of growth, revealed the Soil Association Certification's annual UK Organic Market Report 2021

Speaking at Dairy-Tech 2021, Harriet O'Regan, Arla Foods Category director and Director of the Organic Trade Board, said consumers were consuming more organic food, more regularly.

She said the most common driving factor for organic was health, but issues such as sustainability were increasingly driving people.

"Covid-19 has not dented climate concern. Nearly three-quarters of consumers want brands that reflect personal values," she added.

"The story that we are telling is absolutely what people want to hear."

Stuart Roberts, NFU deputy president and organic farmer, questioned whether the success had been driven by the word organic or by the stories and brands which happen to be organic.

"People buy stories, buy provenance and buy trust," he said.

Ms O'Regan said consumers had found online shopping during the pandemic and they did not expect that to change.

"Organic has benefited. It is easier to find organic. In the supermarket it is

really hard," she said.

Despite growing demand for organic produce, a gaping hole in Government policy on organic has left the amount of organic land in the UK static.

Farmers were interested in conversion but a lack of support from Government was holding them back.

Roger Kerr said there was a 'gaping hole' in the Government's policy on organic.

"OF&G has recorded an 85 per cent increase in enquiries, but ongoing transitional uncertainty around Government support for the sector means many are undecided about whether to proceed. Unfortunately, we are in a 'catch-22' situation and hope the EOF report will provide a route forward."

OF&G welcomes Sustainable Farming Incentive

Alongside other organisations in the sector, OF&G has tried to help Defra understand the value of ensuring organic land management is integrated in future policy. OF&G chief executive Roger Kerr said their collaborative voices appear to have been heard.

"As a sector, we've been striving to highlight the multiple proven benefits



and public goods that organic systems simultaneously deliver against the sustainable standards that Defra is seeking to implement," Kerr said.

He added: "The policy paper states the SFI scheme is 'intended to reward farmers for delivering environmental benefits across all farming systems, including organic farms.'

"It may only be three small words but after months of work it feels like the value that organic farming can deliver is now beginning to be recognised."

He stressed that "consistent" levels of support are vital in helping primary producers maintain economic viability and transition to farming systems that deliver multiple public goods, adding that the organic sector can help Defra achieve its ambition to deliver its 25

Year Environment Plan and carbon net-zero targets.



UK Control Body Recognition

There has been a significant issue that is substantially affecting exporting and re-exporting of organic un-processed foods and feeds as a consequence of the terms of the organic trade agreement within the annexes of the UK/EU Trade and Cooperation Agreement (TCA).

The issue relates to the paragraph in Appendix A of ANNEX TBT-4 of the TCA which states "The organic products listed in this Appendix shall be unprocessed agricultural or aquaculture products produced in the United Kingdom or processed agricultural products for use as food or feed that have been processed in the United Kingdom with ingredients that have been grown in the United Kingdom or that have been imported into the United Kingdom in accordance with United Kingdom laws and regulations."

As you will see there is no provision for food or feed that is not processed in the UK. This means that products or ingredients produced outside the UK cannot be imported and then re-exported to the EU or NI where no further processing within GB has taken place.

This also represents a huge problem with organic products that have not undergone further processing within the EU coming from the EU to the UK, which will become apparent once EU operators have to complete COIs to import (1 January 2022). The six UK Control Bodies (CBs) have been recognised as equivalent and listed in Annex IV of Commission Regulation 1235/2008. It is understood that within the scope of this recognition we can facilitate this activity outside of the scope of the TCA; however, the GB-BIO codes relating recognition were removed from TRACES NT following the agreement of the TCA in December.

Once the issue with re-exporting food and feed products that have not undergone further processing within GB came to light in the middle of January, all the UK CBs requested the reinstatement of their respective GB-BIO codes. The Soil Association Certification has had their code reinstated. However the other five CBs (Biodynamic Association, Organic Food Federation, Organic Farmers & Growers, OF&G (Scotland) and Quality Welsh Food Certification) have so far not had their GB-BIO codes reinstated. The reason for this inconsistency has yet to be explained by the EU Organic Unit. UKOCG has spoken to Elena Panichi (Head of the EU Organic unit) a number of times now and she has indicated that our request for the GB-BIO codes for all six UK CBs to be made available on TRACES NT has gone to their legal team. It is important to note that all six CBs have been recognised as equivalent and their respective GB-BIO codes were made available on TRACES NT at the end of December 2020. Elena said she can't provide a definitive timescale for a resolution, which is unacceptable given the inconsistency that currently prevails in the UK.

The current position as we understand it is that the EU Commission intend to move all UK CBs from Annex IV (individual CB recognition) to Annex III (recognised Third Countries) in early May. This will mean that all trade in organic products that have not undergone further processing will no longer be able to be facilitated by UK CBs within GB immediately thereafter.

The issue is that after 40 years of integrated trade, UK businesses (with established trade routes) cannot simply change the way they do business overnight. The limitations of the TCA around the import and re-export of organic food and feed (where no

further processing takes place) from the UK and to the UK will have a significant impact and businesses need time to adjust. This impact is difficult to assess currently but many businesses that have historically had ties with European processors and importers are being severely affected and are now undoubtedly losing hard won markets.

To help resolve this OF&G (through UKOCG) have written to the Cabinet office and UK Trade Mission in Brussels asking that they request all the GB-BIO codes to be reinstated until 31st December 2021 to allow for a transition.

It is understood that a precedent has been set by the EU when the EU/Chile equivalency was agreed by allowing those Chilean CBs that were recognised under Annex IV to retain their recognition for six months.

We are therefore calling for the following:

- UK operators need time to adjust, all UK CBs therefore need recognition to be retained in Annex IV until 31/12/21 as originally indicated when the update in Annex IV was published late last year
- That ALL the GB-BIO codes are reinstated immediately to allow for this transition and to not unfairly penalise operators that are not certified by a CB that has a GB-BIO reinstated or obliging them to transfer to the CB that has access to their GB-BIO code on TRACES NT. This represents anti-competitive activity by the EU COM
- That the paragraph in Appendix A of ANNEX TBT-4 of the TCA to be reworded to reflect the current UK/US equivalency

which states "The arrangement is limited to organic products of US or UK origin. This includes products that have been either 1) produced with the US or UK or 2) products whose final processing or packaging occurs within the US or UK. This includes products processed in the US or UK that

contain organic ingredients from foreign sources that have been certified to the US or UK organic standards" - this is a mirror of the EU/US equivalency agreement

We have still to hear when they will be reinstated but Roger Kerr (CEO and Chair of UKOCG) is in regular contact

with colleagues in Europe (European Organic Certifiers Council (EOCC) and IFOAM Europe along with Defra and the UK Mission in Brussels pressing for a resolution. We hope to have some good news very soon.

TRACES Registration Reminder

As we move into the second quarter of 2021 OF&G are still seeing a number of operators experiencing difficulties exporting organic goods to the European Union (EU) and Northern Ireland (NI). There may be a number of reasons for this, one of which is the need to be registered as an organic exporter with both OF&G and on TRACES NT. If you are exporting or intending to export organic goods to the EU or NI and you haven't already done so there are two important actions for you to undertake:

- Contact your certification officer at OF&G to discuss the requirements in order that your scope of certification and thus certificate of compliance can be amended to include 'Exporting';
- Register yourself on TRACES NT.
 Once this has been completed you will be able to assign an activity as an 'organic exporter'.
 OF&G will receive notification of the registration and, provided all information is correct, will validate the registration.

Once OF&G have been able to validate the registration you will be able to produce the COI for exports of organic goods to the EU/NI.

Paper COI for imports from outside the EU

If you are importing organic goods into the UK from outside of the EU you will need to ensure the UK's revised COI system is followed. Unlike the EU's import system (TRACES NT) there is no on-line database for imports into the UK and a paper based COI must be completed by the CB of the exporting operator in the third country. Defra has recognised the third countries and CBs deemed equivalent by the EU as of 1 January 2021 as being able to certify export to the UK and has notified them of the UK's revised import regime. Following recent discussions with Defra and other UK CBs there is concern that not all organic goods from these third countries are being imported into the UK with the correct paperwork.

As the importer within the UK you are responsible for ensuring all products are brought into the UK with the correct, compliant paperwork. The paper COI must be signed and stamped by the exporter's CB prior to the product leaving the country of export. You must inform the Port Health Authority (PHA) of the impending import of organic goods into UK; this will allow the PHA to undertake the relevant checks and endorsements of these organic goods and paperwork, including the additional requirements for high risk goods originating from Ukraine, Kazakhstan, Moldova, Russian Federation, Turkey and China.

Ending of Easement for COIs from EU

Following the UK's exit from the EU the need for documentation to support organic imports into the UK moved away from the EU's on-line COI system (TRACES NT) to a paper based system implemented by Defra and the Port Health Authorities, as detailed above. Following numerous discussions, Defra agreed to the implementation of an easement against the requirement for a paper COI, meaning that any

imports of organic goods from the EU would not require a copy of the COI to accompany the goods until 1 July 2021. The Government has announced a further extension of the easement to 1 January 2022. This means that from 1 January 2022 any organic goods imported into the UK from the EU will require the CB of the exporting operator within the EU to produce and sign a copy of the Defra COI prior to the goods leaving the country of export. As the importer within the UK you are required to inform the PHA at the clearance port of the impending import of organic goods.

Whilst this easement will be in effect until midnight on 31 December 2021 it is important that you as the operator importing products from the EU are informing your suppliers (exporters in the EU) of these requirements and the need for them to speak to their CBs.


