**Valid from 1/12/2018.** Fees are under review and may be revised at any time. The fees relate to inspection and certification charges but do not guarantee that a Certificate of Compliance will be issued.

The Introductory Fee for producers is at a fixed rate for the first 22 months and is regardless of size of holding. Year 1 is 10 months from the date the land begins its conversion, not the date of application. This is so that further annual inspections can take place before the land completes its 24 or 36 month conversion period and allows the products to be certified organic before they are marketed. Fees only apply to areas registered as organic or in-conversion, not to areas under non-organic management.
